APPLICATION INSTRUCTIONS:

Enviro P can be applied through fertigation or conventional spray. It can be applied alone or tank mixed with other products. One gallon of Enviro P contains 2.22 lbs. of phosphorus as P_2O_5 and 0.74 lbs. of nitrogen. Refer to the table below to determine the volume of fertilizer to apply to achieve the desired amount of phosphorus. Apply Enviro P diluted with 2 gallons of water per 1,000 sq. ft. or 80 gallons of water per acre.
